
## Prevalence of Any Substance Use 2014:

- Among the 17 substances asked about in CISDUS 2014, the most prevalent substance used was *Alcohol*. About 38.1% of students surveyed reported drinking in the past year.
- The second most commonly used substance was *Ganja* (18.8%), followed by *Tobacco* (9.8%), *Tranquilizers* (4.3%), and *Donkey Weed* (local bush) (2.7%)
- The remaining substances were used by 1.6% or less of students.

# Cayman Islands Student Drug Use Survey CISDUS2014

## MULTIPLE SUBTANCES USE\* AMONG STUDENTS IN THE CAYMAN ISLANDS 1998-2014

## Trends in Multiple\* Substance Use:

- There was a slight decrease of "no substance use" between 2012 (53.0%) and 2014 (52.4%).
- The percentage of students that restricted their use to tobacco only decreased during the same period.
- Exclusive Ganja use has increased notably over time from 0.5% in 1998 to 6.0% in 2014. Exclusive Alcohol and Ganja use increased from 3.9% in 2012 to 5.8% in 2014.
- Exclusive Tobacco use decreased over the years from 1.1% in 2010 to 0.5 in 2014.
- The consumption of "Exclusive other illicit drugs" increased from 0.8% in 2012 to 1.2% in 2014.



#### \*Multiple Substance Use, 2014:

More than half (52.4%) of all students reported no substance use at all in 2014. About one-fifth (20.1%) of students reportedly used only alcohol. Very few students used Tobacco exclusively (0.5%) and ganja exclusively (6.0%). About 1.2% use another drug exclusively.

Very few students (2.5%) reported using all drugs: alcohol, tobacco, ganja and other illegal drugs. Similar percentage was reported among students that reported use of alcohol, tobacco and ganja exclusively (2.3%). Students that reported the use of alcohol and ganja exclusively was 5.8%.
